I wanted to give you a heads up in case you get any inquiries about EPA. We're in the process of conducting packer tests on several large boreholes throughout the site, mostly on our property, YMCA, and Tony Roni's. Our subcontractor encountered LNAPL (high-concentration PCP oils) in one boring latelast week. The packer testing equipment needs to be decontaminated b/w each boring, and the LNAPL adds an extra layer of effort. We also have a health and safety aspect for those crew working over thehole or doing decon. So, we are going to be taking an air sample from the decon material and the decon crew will be wearing Level C PPE, i.e., Tyvek, heavy duty gloves, respirator (not SCBA). The decon areais located on our property behind the current temp plant which is housed by the very large tent. We have a secondary containment unit set up and it will not be an issue to implement. However, someone who sees crew out there in Tyvek and respirators may raise questions. This happened before when Mr. Storage was digging for the SWM system. So, I just wanted to let you all knowin case anyone asks. Rep. Vitali previously asked about the temp plant building and it's appearance, which tells me that he or one of his staff pass by there sometimes too.

This type of decon and PPE will only be for borings that have LNAPL, but it's not clear if any remainingborings will meet this criteria. It may be a non-issue. It also should all be completed by NLT <u>3/11/22</u>.

S. Krakow inquired about retrofitting fossil fuels for new builds or banning new fossil fueled construction. P. Puglionesi replied we are working on a green point system to encourage and incentivize reduction in fossil fuels.

Background on Low Emission Vehicle Parking at the CREC

Two years ago, the EAC requested an ordinance update (concurrent with a request for EV charging parking enforcement) to allow enforcement of the current "Low Emission Vehicle" parking area at the CREC, which was implemented to achieve LEED Bronze certification "equivalent". It is not legally enforceable and usually full of high emission vehicles. The Township said they would consider it a later date. At the Quarterly Climate Meeting in September, we brought up the parking at the CREC. A discussion between EAC members made it clear that the topic was worth revisiting at the next EAC meeting. The vote of the EAC on this topic will decide if changes to the current status are suggested at the next Quarterly Climate Meeting for reassessment by the township.

Vote proposed.

Ordinance change (below) providing for enforcement of "Zero Emission Vehicle (ZEV)" parking areas on township property with a likely change in signage.

Arguments:

For change in ordinance to enforce ZEV parking.

High emission vehicles parked in the low emission spots normalizes the ignoring signs in general and may discourage CREC attendance by people who own low emission vehicles. LEED criteria have evolved away from "low emission vehicles" which is a vague and hard to understand term. Preferred parking may bring attention to the existence of EVs to those who are not aware of them and is consistent with the Township's intent to follow LEED certification criteria. Changing the current signs to ZEV parking would be a Township decision.

Against

ZEVs have become a lot more mainstream and better parking spots at the CREC may not persuade individuals to purchase electric cars. If the parking spots are unlikely to persuade individuals to purchase an electric or low emission cars, perhaps the benefit of the signs may be to draw attention to the fact that low emissions vehicles exist. Since that is already the current situation, it is not worth the time to pursue the ordinance change or money in getting new signage.

ORDINANCE NO. Pxx-2022

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, FURTHER AMENDING AND SUPPLEMENTING ORDINANCE NO. 1960, ADOPTED JUNE 30, 1986, AND KNOWN AS "GENERAL LAWS OF THE TOWNSHIP OF HAVERFORD" CHAPTER 175, VEHICLES AND TRAFFIC.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

SECTION 1. § 175-32. Parking on public property.

- A. It shall be unlawful for any unauthorized person to park any motor vehicle on any public property of the Township of Haverford in parking areas restricted and otherwise reserved for official use by Township officials and employees.
- B. It shall be unlawful for any unauthorized person to park or otherwise leave unattended any motor vehicle on any grounds or parking areas of the Township of Haverford, except persons conducting Township-related business, between 8:00 a.m. and 9:00 p.m., Monday through Sunday, and as further set forth in § 175-32I(3).
- C. For purposes of this section, Township-related business includes the use of all Township facilities at the Municipal Complex, including the Skatium and adjacent parks and fields.
- D. It shall be unlawful to park or otherwise leave unattended any motor vehicle on any grounds or parking areas of the Township of Haverford for periods exceeding three hours, except persons conducting Township-related business
- E. This section shall not apply to public parking areas designated as such with parking meters.
- F. Any motor vehicle found on public property of the Township of Haverford in violation of this section shall be removed and impounded as provided in Article IX.
- G Regulations controlling and restricting the movement and parking of vehicles are hereby established upon all parking lots, parks, playgrounds and other municipally owned or leased properties in accordance with this chapter and pursuant to the provisions of Chapter 126, Public Parks and Playgrounds, § 126-3, General regulations governing parks, Subsection H.
- H. For purposes of this section, an "electric vehicle charging station" means a public parking space that is served by charging equipment that has as its primary purpose the transfer of electric energy to a battery or other energy storage device in an electric vehicle.
- I. Any parking space with an electric charging station used for charging plug-in electric drive vehicles must have signage indicating that the space is for the exclusive use of plug-in electric drive vehicles. Only plug-in electric drive vehicles may park in such parking spaces, subject to the following limitations:
 - (1) The use of a charging station shall be available on a first-come first-serve basis.
 - (2) All vehicles parked in a space containing an electric vehicle charging station must be connected to and using the charging station equipment to charge the vehicle.
 - (3) Plug-in electric drive vehicles may be parked in electric vehicle charging station spaces, while charging, between the hours of 9:00 p.m. and 8:00 a.m.
 - (4) It shall be unlawful to park or otherwise leave unattended any motor vehicle at an electric vehicle charging station for periods exceeding three hours.
 - *J. Any parking space reserved for a "Zero-Emission Vehicle" must have signage indicating that the space is for the exclusive use of Zero-Emission Vehicles".

- (1) For the purpose of this ordinance, a "Zero-Emission Vehicle" or "ZEV" means a vehicle that does not directly produce atmospheric emissions of any criteria pollutant (or precursor pollutant) or greenhouse gas under any possible operational modes or conditions, such as a Battery Electric Vehicle. A hybrid vehicle or plug-in hybrid electric vehicle is not a zero emission vehicle.
- (2) It shall be unlawful to park or otherwise leave unattended any motor vehicle at an in a space reserved for a "Zero-Emission Vehicle" except for a "Zero-Emission Vehicle".
- <u>K.(5)</u> The owner of any vehicle in violation of this section may be issued a citation and shall be subject to a \$10025 fine for each day of violation. In addition, the vehicle in violation of this section may be towed at the owner's expense.

SECTION 2. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the designated section or zones giving notice of the regulations aforesaid.

SECTION 3. Any ordinance or part of an ordinance to the extent that it is inconsistent herewith is hereby repealed.


