Senior Citizens' Advisory Council Minutes for 6/18/2024

As a point of information, Aimee informed us that there was no requirement for a quorum for our meetings, as long as the majority of the council is present.

The Council voted to cancel summer meetings since many people are on vacation. We will reconvene in September 2024. Aimee informed us that would be room in the Fall newsletter for a small article from our Senior Citizen's Council if anyone is interested in writing one.

The minutes from the May 2024 meeting were approved. Aimee again reviewed the new requirements for the ADA compliant documents. Everything should be submitted in WORD, left justified, no indentations, no bolding, no underlining, and mixed case is okay (not all CAPS).

There was no Co-Chairs report.

The 11/3/2024 Senior Open House event at the CREC was reviewed. The decoration theme will be an Eagles' tailgate. The Eagles' game will be played at night so there will not be any conflict. It was agreed that while Chris McLaughlin's speaker suggestion, Mindy, would be good for another program, the focus of this event was on senior health and personal maintenance. Peggy reminded us that the CREC was co-sponsoring the event. The CREC staff will have several speakers of their choosing for this event, and Carla will speak on "good news for your aging brain." Gerry Hart had talked about speaking as well, but had not followed up with any of us, and the program should be full enough as is. Chris did the last year's Open House, and may need a co-chair this year, or not. Several members offered to help. The Township/CREC will handle the vendors.

Margaret, who was not present, had talked to Peggy about a new minute's template. Aimee informed the council that the intern's tenure with the township is over. Again, we agreed that a briefer summary of the senior questionnaire for the website would be better, since the current detailed summary has been up for a while.

Aimee will be contacting the commissioner for the 9th ward to appoint someone for the council.

It was suggested that at each meeting one of the council members take a few minutes to describe their own backgrounds so we can get to know each other better.

Peggy reported that she received the Council materials from Scott before he moved to South Carolina. No decision was made on what to do with these materials.
