•This was the reorganization meeting and Henry Eichman was nominated by Judith Venuto and second by Bryce Carter for President, with no other nominations Henry Eichman has remained President for 2021. Catherine D'Orazio was nominated for Vice President by Bryce Carter and second by Henry Eichman for 2021. There being no other nominations Catherine D'Orazio will be Vice President for 2021.

The meeting was called to order by Mr. Henry Eichman at 7:05 pm.

The minutes from December 8, 2020 were distributed and approved.

- The Haverford Township website has been updated to provide the most recent information and links for Covid -19 testing and immunizations locations. The site will continue to be updated along with the information being placed on social media. Discussion ensued.
- Calls have been coming in concerning registering for the Phase 1A and 1B vaccine distribution. Those residents have been provided links and/or phone numbers to complete their vaccine interest form. There is a lack of information to answer all their questions at this time, but we continue to be advised as the County and/or State put out news releases. <https://chesco.org/4822/COVID19Vaccine>
- Delaware County had announced their will be three large distribution areas, located in the eastern, central, and western parts of the County. The eastern location will be in Yeadon. They have not announced specifics on the other two locations. They will also network with private stakeholders which includes private healthcare providers, pharmacies, clinics, hospitals, community service organizations, and mass vaccination events. Discussion ensued.
- The Delaware County Health Department Steering Committee will be accepting applications for their Board of Health until January 29, 2021. <https://www.delcopa.gov/clerk/boardpositions/DelawareCountyBoardOfHealth.html>
A time-line is set for having a Public Health Department up and running in January 2022. Currently they are meeting elected officials, faith-based groups, and other community groups in the County to assess the needs they feel are important.
- Governor Wolf's most recent Covid mitigation restrictions including the additional restrictions for Delaware County have been lifted. The indoor dining is permitted to return to 50% occupancy. Gyms and indoor sporting events may resume. All will still require masking and social distancing.
- Dr. Amanda Jones, PsyD will be joining the Health Advisory Board. She will be filling the spot vacated by Susan Barb.

•A resident contacted a commissioner concerning her neighbors' cats running at large. She is requesting an amendment to the Animal Control Ordinance to include domestic felines. Dr. Hart requested The Health Advisory Board review and discuss it. The board has agreed to look further into environmental impacts and bacteria virus transmission to humans along with general nuisance and property maintenance issues. Discussion ensued.

•A phone line for questions about the COVID-19 Vaccine in Delaware County, call the Delaware County Call Center at: 484-276-2100. There have been a number of senior citizens calling the township looking for vaccine and unable to register without a computer. The County has also put out a list of locations that will be providing the vaccinations. The state has plans to open some mass vaccinations in each county. It still appears getting vaccine remains the problem.

•Kitchen inspections have been scheduled for all nursing and senior living facilities. School facilities are also having prearranged inspections due to the admittance issues with Covid mitigations in place. None of these locations has had any major violations in the past.

•We are continuing to follow up on any complaints we receive concerning Covid-19 Mitigation requirements. Other complaints continue to come in for rats, trash, and snow covered sidewalks. All are being investigated.

•This would normally be the time we would be making plans for our annual Rabies Inoculation Clinic but it will be put on hold at this time.

The minutes from the February meeting were circulated and approved.

- March being National Nutrition Month it was proposed by Cathy D'Orazio to promote nutrition awareness and education in the community and try to start an initiative with healthier options offered at restaurants. Cathy did put together a Proclamation that was read at the Commissioners Meeting last night declaring March National Nutrition Month. Social media will have nutrition information posted every other day from Academy of Nutrition and Dietetics. Discussion ensued

- Ideas involving promoting food establishments for healthy dishes have been curbed. The Township will not mention any establishments by name on social media. They are not permitted to advertise/promote any business of any kind. It may be possible to send emails to the food establishment encouraging them to create and/or promote healthier options. Discussion ensued.

- Animal control ordinances from Lower Merion, Upper Darby and Marple Townships do not allow domestic cats to run at large. Springfield Township allows cats to run at large. Radnor Township

only urges residents to keep cats indoors when there has been a confirmed case of rabies. All ordinances have been attached. Discussion ensued.

- There will be an upcoming Meeting with Chad Kennard from Delaware County. He will be providing information on the county's mosquito control and West Nile Surveillance program for 2021.

- Complaints are being investigated including trash containers, bulk trash items and rats. Follow-ups have been done on a property that was deemed Unfit for Human Habitation. The owner was able to pay a company to go in and get it cleaned and sanitized.

Meeting was called to order at 7:05pm by Mr. Henry Eichman

The minutes from the November 9, 2021 meeting were circulated and approved

- Four Bird Distilling/Side Bird Kitchen was inspected and approved on November 12th. They are located at 1901 Darby Road.
- The Delaware County Health Department submitted their application to the state to become a County Health Department under Act 315 on December 9th. The Bureau of Environmental Health is currently holding Town hall meetings in person and as a webinar. They are reaching out to Local Municipalities and Business owners to clarify the requirements for applications and inspections. The Bureau of Environmental Health will also handle the Swimming pools and to some extent the vector control issues. The other department will be Personal Health and Population Health. At this time, we have not been contacted by any other Bureaus to inform us of contact information or services they will be providing.
- Influenza shots and other vaccines distributed at the pharmacies were discussed.
- Currently we are licensing all of the Retail Food Businesses whose licenses expire on December 31, 2021. Invoices have been mailed within the past week and yearly inspections are being completed.

- Citations will be issued for the property on Lawrence Road for non-compliance for insanitary conditions and plumbing problems that have not been resolved.
- Continued work on complaints, involving composting, weeds, rodents, chickens, leaf piles etc. are being investigated.

The meeting was adjourned at 7:45 pm.
